Kipona & Private School Partnership Transition Scholarship Program Fact Sheet

This fact sheet is designed to help you understand and compare the Kipona Scholarship Program and the Private School Partnership Transition Scholarship Program

KIPONA

Eligibility:

 Determined annually based on the family's <u>financial need</u> and recognized tuition costs of the private school. <u>Participating</u> <u>schools</u> are listed on the KS website.

Flexibility in School Enrollment:

- Award <u>may be used at another participating school</u> if the recipient does not enroll in the school identified on the award letter
- Non-transferable to another grade, student, school year, or KS program.

Federal Income Tax Return

· KS will request your tax form to verify financial data.

Award Adjustment:

 Initial award amount is the maximum and may decrease based on actual tuition costs.

Minimum Family Contribution

 Families must contribute a minimum of \$100 annually towards the recipient's tuition, already included in the award.

PRIVATE SCHOOL PARTNERSHIP TRANSITION (PSPT)

Eligibility:

- Must have received a KS-funded scholarship at one of the specified schools in 2024-2025.
 - Aka'ula School
 - Assets School
 - Island Pacific Academy
 - Island School
 - o St. Andrew's Schools
 - St. Louis School

Termination of Award for Non-Enrollment:

- If not enrolled and attending the specified school, the award is terminated, and the student is ineligible for future years.
- <u>Non-transferable to another school</u>, grade, student, school year, or KS program.

Fixed Award Amount:

 Set at the amount received in 2024-2025 and will not be adjusted.

--- REQUIREMENTS THAT APPLY TO BOTH KIPONA AND PSPT---

RECIPIENT RESPONSIBILITIES

- Must complete your Private Schools' requirements to progress to the next grade level.
- Recipients must reapply each year, meet all eligibility requirements, and submit completed applications by the deadline. For non-entry grade levels, applicants need renewal status from the previous year.
- Must fulfill assessment and/or testing requirements as notified by KS.
- Must fulfill the agreed upon terms and conditions when accepting awards.
- Failure to meet the responsibilities may result in ineligibility for next school year (2026-2027).

E Kōkua Kākou (Community Service)

Voluntary work intended to help and support people, organizations, or the environment in a specific community
