To the Selection Committee for Trustee:

Olin Kealoha Lagon would make an outstanding trustee for Kamehameha Schools. His Native Hawaiian roots, lived experience growing up in Kuhio Park Terrace and lifelong focus on serving the community are exactly the kind of qualities needed to guide an institution with such a deep kuleana to our keiki. Everything he does points back to creating real, practical opportunities for Native Hawaiians and other underserved families, not just talking about change but actually building it.

Olin's work as a founder and technologist shows how he thinks in systems and at scale while staying grounded in Hawaiian values. He helped pioneer online crowdfunding with ChipIn and later co-founded Shifted Energy, which turns ordinary water heaters into tools that support Hawai'i's clean energy transition and bring benefits to renters and low-income households who are often left out of the renewable energy story. That balance—technical excellence, business sense and equity at the center—is the same balance Kamehameha Schools has to strike every day as a major educational institution, landholder and community leader.

I invited Olin to participate in the Art+Design+Architecture panel hosted by AHL and entitled, "Hawai'i's Way of Life as a Compass for the World," and continue to have people remark on how inspired they were with his remarks. Olin framed Hawaiian values not as a theme but as a real decision-making framework for design, technology and the way we build our future. He talked about how ideas like interconnectedness and reciprocity can guide choices so that projects actually strengthen community and place, rather than just looking Hawaiian on the surface. That kind of thinking—moving easily between traditional knowledge and modern systems—is exactly what is needed in KS leadership as it navigates everything from education strategy to land use and innovation.

On a personal level, what stands out most about Olin is his consistency. His communications on social media are thoughtful, frequently eye-opening and inspiring. He spends time with students, including those from Kamehameha Schools, showing them that they can be both tech leaders and strong in their identity as Hawaiians. Even as his companies have reached impressive milestones, including Shifted Energy's acquisition, he keeps bringing the focus back to community impact, climate action and lifting others up. That humility, paired with big-picture thinking, is a rare combination.

Speaking as someone who works in PR and mentors entrepreneurs in Hawai'i's ecosystem, Olin is exactly the kind of leader people trust and want to follow. He communicates complex ideas in a grounded, relatable way, helps other founders and uses his platform to create more room at the table rather than to center himself. I would like to submit comments in support of Olin Lagon being selected as the next Kamehameha Schools Trustee. He is one of the most brilliant people I know, not just in his intellect and innovation, but in the aloha that shines through his every interaction.

He is also considerate of his lo'i neighbors and takes care of the lo'i nearby that are overgrown--they are not his kuleana but he helps them anyway. He is inclusive and always allows us to just show up, invites other friends and colleagues to join, and thus serves as a connector of people and 'āina and provides healing and restorative interactions and spaces for us in a truly grass-roots way.

Olin Lagon is humble, honest, transparent, innovative, compassionate, open-minded, and solution-oriented. He has a rare gift of the balance of being a tech/engineering genius AND kind, generous, and collaborative. He is not someone who just preaches aloha or uses it as a PR strategy; he does not just talk about change but he actually does the research, uses data, gathers input, and dreams up and implements change strategies; he lives the values of Kanu Hawai'i, and acts as an individual with aloha and commitment to a better Hawai'i, and models for the community what true leadership looks like. I

Public Comment – Trustee Finalist Olin Lagon

This is a Recommendation Letter for **Olin Lagon** for the position of Trustee for Kamehameha Schools.

To summarize: Olin and I met at Hawai'i digital tech and startup conferences after I returned to Hawai'i (I spent 20 years in Tokyo with M.I.T., AOL, Google, and startups). I am currently in management consulting and on the Advisory Board of the University of Hawaii Computer Science Department. I speak 'olelo Kepani and some 'olelo Hawai'i. I have published essays on our Kingdom leaders and have lectured on our King Kalākaua to the Royal Order of Kamehameha, Oahu Chapter.

My linkage to Olin is that I grew up in Kalihi (Fern, Kalakaua, FHS), like Olin. We are both Farrington alums (Hulu Lindsey of OHA is a FHS alum). I see Olin as an authentic "Keiki o ka Kalihi-Palama". But that is not all – we both share experiences in startups, digital technology, and most importantly, we are both deeply interested in educating younger generations, especially in economically challenged communities, like Kalihi-Palama.

I led the UH CS Dept. to teach a college-level CS Intro course to a King Kalākaua Middle School cohort of 7th and 8th graders. At Farrington High School, I brought Hawai'i and Silicon Valley tech speakers (Apple, Amazon, Google, Facebook -- some from Hawaii) to the FHS "only" CS class (for 2,700 students).

When I told Olin about my "TSMI" Kalihi project, he responded quickly by gathering free laptops for our cohort. He gave his valuable time to our team, giving us insights from his Purple Mai'a project: Olin is one of the few kanaka maoli who, like our King Kalākaua – an "early adopter" of technology and science – has a vision of kanaka maoli children who excel in science,

engineering, and entrepreneurship -- while still honoring the legacy of our Host Culture and our kūpuna and their teachings for us all. He is exemplary in living “Ho‘oulu Lāhui” or “To grow the nation/people”. Olin’s work in Purple Mai‘a is a showcase in providing computer science classes rooted in Hawaiian ‘ike and in economically challenged communities.

Olin has “lived experiences”, growing up in underserved neighborhoods and returning to stand before children and say: “I am one of you.” Very few individuals can say that. Children know what is authentic and what is not. Children believe in Olin – he speaks from his heart and the truth. Remarkably Purple Mai‘a in less than a decade has developed into the state’s largest Hawaiian values-based STEM organization. Olin poured his heart, his decades of insights in STEM and startups into the project – a lot of hard work. He follows the saying “E lawe I ke a‘o a mālama, a e ‘oi mau ka na‘auao”: He who takes his teachings and applies them increases his knowledge.

Olin imbues Hawaiian values not only in digital technology education and training, but also in entrepreneurship and workforce development. Olin BELIEVES in our keiki – to create the next Google – employing talented local people for a diversified economy, to “own” 21st century tools like Software Engineering, Data Sciences and Artificial Intelligence. Not only does Olin have passion and Hawaiian values – he plans, LISTENS to many stakeholders, reaches consensus, develops a strategy, and organizes the community to execute on goals and priorities. I am sure he will do the same at Kamehameha Schools – if not more, to a much higher level. He is the living embodiment of the motto: “Nurture the child and the lāhui thrives”.

Lastly, Olin is never a person to say “No”: When I advised an annual cohort of researchers from Western Washington University (my alma mater) on a Hawai‘i study mission, Olin came to talk about his startup Shifted Energy and energy issues – the students were impressed by his knowledge and inclusiveness. Again, this is example of Olin’s commitment to students – he

SHARES his knowledge to youth. He is humble. To be humble is the core of Hawaiian culture – the word “ha’aha’a” means being open to giving and receiving help, valuing our ‘ohana (family/community), and understanding that true strength (not physical – but spiritual, from the heart) comes from connection, not superiority, making it essential for learning and building healthy relationships. This is Olin’s “foundational belief” for making decisions, to respect others (and that is also from our Kalihi-Palama background – although we may not have much in the way of material goods, we respect each other and always help each other).

I can think of no other individual who can meet the challenges of kanaka maoli keiki in the 21st century – the most significant societal (and education) trends for the next 100 years will be AI and Data Science -- a technological revolution that must be leveraged in the right ways for a sustainable, equitable society.
