I am writing to express my strong support for the selection of Eric K. Yeaman as Kamehameha School's next Trustee. Dear Committee –

I am writing to express my profound support of Eric K. Yeaman's candidacy for appointment as a Trustee for the Estate of Princess Bernice Pauahi Bishop and of Kamehameha Schools ("Trustee").

I was born and raised in Hawaii, and my family and ancestors have called Hawaii home for 5 generations and counting. I graduated from Kaiser High School in Honolulu, continued my formal education in California, and spent the first decade-plus of my career working and learning at large, global corporations, primarily in the realms of corporate finance and strategic planning. I returned to Hawaii in 2017 so that my children could be raised in this very special place.

As I review your desired qualities and characteristics, I firmly believe Eric is best suited for the role of Trustee. Not only does Eric meet and exceed each characteristic and qualifying measure, but he also possesses a unique combination of heart/care, integrity, experience, relationships, and intellect to effectively collaborate with the broader Board of Trustees toward the fulfillment and sustainment of the "vision, mission and values of Kamehameha Schools" benefiting native Hawaiians. I hope the following examples will help bring some of these words to life:

- **Heart/care and relationships:** I came to know Eric from a "cold" outreach via the professional networking website, LinkedIn. To my surprise, Eric graciously responded to my outreach within an hour or two, and he subsequently set aside time to meet with me and learn about my background. Aside from my personal interactions with Eric, I know that he dedicates time to mentor young professionals formally via organizations such as the Chamber of Commerce of Hawaii and informally through other channels.
- **Integrity / Pono:** I recently encountered a situation with respect to a client-service

relationship that though not a "conflict of interest", could be perceived as one. I shared the situation with Eric, and he agreed that I should proactively share the facts with my client as (in his words), "transparency is the best policy".

- **Experience and intellect:** When I consider Eric as a seasoned executive and corporate Board Member, I think of someone who is the consummate professional, yet humble and approachable. In terms of style, while many of us in Hawaii can wrestle with cultural norms of conflict avoidance when juxtaposed with professional responsibilities to sustain and improve an organization, Eric deftly navigates being respectful and courteous, with the need for and importance of "speaking up" – to share input and provide direction. 



I want to provide my strongest support for the appointment of Trustee Candidate Eric Yeaman as a Trustee of the Kamehameha Schools. I have known Eric Yeaman personally and professionally for over twenty years and I don't know of anyone who possess a greater reputation of integrity; successes in managing large corporations; proven expertise in business, finance and investment; successful history of strategic planning and policy setting; and possessing impeccable character and personal traits such as pono, 'imi 'ike, laulima, lokomaika'i, na'au pono, malama, and ha'aha'a.
