# Census 2000 Highlights: Hawaiians in the United States and Hawai'i

### Hawaiians in the United States

The U.S. Census launched a brand new approach in the year 2000 with a novel reporting format for race and ethnicity. For the first time in history, individuals were offered the opportunity to report multiple races. Although the new format limits our ability to estimate population growth by race since the last census, many individuals argue that it more adequately reflects their true racial identity. Another change in the Census 2000 was a new category added for Native Hawaiians and Pacific Islander Americans (NHOPI). This feature altered the standard reporting practice in prior years of collapsing the NHOPI with Asian Americans. These changes provide some new insights about people who report Native Hawaiian race in the United States. Note that this report uses both Hawaiian and Native Hawaiian to refer to the Native Hawaiian census category.

- Total Hawaiian population 401,162: A count of all adults and children who identified Native Hawaiian race in the Census 2000 (alone or in addition to other races or ethnicities) reveals a total of 401,162 individuals, or about 0.1 percent of the entire U.S. population. About 35 percent of this total reported only Hawaiian race and no other race. By state, the counts ranged from 239,655 in Hawai'i to a mere 76 Hawaijans in Vermont
- 60% of all Hawaiians live in Hawai'i: Ten states in the union account for 88 percent of the entire population of Hawaiians (see Table 1). About 60 percent of self-reported Hawaiians reside in the state of Hawai'i. California holds the next largest population with just over 60,000 individuals, or 15 percent of the total. Note that more Hawaiians live in California than on the island of Hawai'i and twice as many Hawaiians live in California than on the island of Maui!
- Hawaiians in the NHOPI Census Category: Among the 874,414 NHOPI individuals in the nation, Table 1 shows that slightly less than half (46 percent) reported some Hawaiian race. The proportion of Hawaiians among the NHOPI varied substantially from state to state. For example, in New York, only 13 percent of the NHOPI population reported Hawaiian race, compared to 85 percent of NHOPI in Hawai'i. In most states, about one third of the NHOPI declared Hawaiian race. Note that NHOPI race responses accounted for 0.3 percent of all race responses in the Census 2000, compared to 77 percent White, 12.9 percent African American, 1.5 percent American Indian/Alaskan Native, 4.2 percent Asian, and 6.6 percent Other.
- Single Race Hawaiians 140,652: The final column in Table 1 shows the percent of Hawaiians in each state that identified with no other race except Hawaiian. Overall, just over one third of all Hawaiians reported Hawaiian race only (note that this is a question of racial identity, not blood quantum). In Hawai'i, one third of Hawaiians reported single race, but in other states, many on the East Coast, single race Hawaiians appeared with much greater frequency as a percent of total Hawaiians. Most notably, 59 percent of Hawaiians in Washington, DC reported only Hawaiian race. In part, this may be due to different politicalization about the issue of multi-race reporting and its possible repercussions for affirmative action and/or entitlement programs.

## Hawaiians in the State of Hawai'i

As noted in a prior brief, "Hawai'i State contains a *very* diverse population. Roughly 21 percent of the 1.2 million in the state (about one in every five people) declared more than one race—compared to only 2.4 percent of the nation's total population! Even California State pales by comparison, with only 4.7 percent of its population reporting more than one race" (Kanaiaupuni, 2001).

- Native Hawaiians in Hawai'i 239,655: In 1990, 138,742 individuals reported Native Hawaiian in response to the request to select a single racial identity, accounting for about 12.5 percent of the state population (see Table 2). In answer to the Census 2000 request to select one or more races, 239,655 individuals chose Native Hawaiian, resulting in a higher proportion, 20 percent, of the state's population. This proportion more closely reflects other estimates of Hawaiians in the state, for example, the Department of Health records roughly 22 percent of the state population (see <a href="http://www.state.hi.us/doh/stats/surveys/hhs/hhs00t1.pdf">http://www.state.hi.us/doh/stats/surveys/hhs/hhs00t1.pdf</a>) and 36 percent of births in 2000.
- Native Hawaiians by county, Census 2000: Differences appeared in the proportion Hawaiian *within* each county, shown in Table 2. The county of Hawai'i had the largest proportion of Hawaiians among its residents, comprising 29 percent of total residents on the island. O'ahu contained the smallest proportion of Hawaiians, at 17.5 percent of its residents. The distribution of Hawaiians *across* the counties changed little since 1990. About two thirds of all self-reported Native Hawaiians in the state are still located on the island of O'ahu, 18 percent on the island of Hawai'i, 12.5 percent in the county of Maui, and 5.6 percent in Kaua'i county. Small differences appear in the percent of single race Hawaiians across the four counties, with Maui registering about 38 percent of its Hawaiians reporting no other race but Hawaiian.
- Other information from the Census 2000 about Native Hawaiians: To date, the Census has released population counts for the major subgroups within each racial category. These counts also are available by Census Tract (see report by Alu Like, 2001). Future scheduled releases from the Census Bureau will contain further information available about Hawaiians in the Census 2000.

### A Brief Note on Accuracy in the Census 2000 Coverage

Overall, the latest Census appears to be a big improvement over the last Census. According to the latest report of the Executive Steering Committee for Accuracy and Coverage Evaluation Policy (ESCAP) on October 17, 2001, the net undercount in 2000 was .06 percent, compared to 1.6 percent in 1990. Note, however, that the undercount disproportionately affects minorities, renters, and children, including Native Hawaiians.
